## PAYMENT POLICY AND AGREEMENT

This is a contract. This contract deals with payment matters between Burton Funeral Homes and Crematory, Inc. ("Burton") and Burton's clients. This contract supplements the separate contract entitled "Statement of Funeral Goods and Services Selected."

With the intent to be legally bound, the parties agree as follows:

1. Because Burton is a small business, providing services and merchandise, Burton is dependent on its clients for prompt payment.
2. Burton makes payments to third parties such as cemeteries, churches, clergy and organists. The client will provide Burton with cash or check before the funeral service so Burton can, in turn, make these payments.
3. Payment to Burton for its services is also due before the service. Payment may be made by cash, personal check, bank check, money order, Visa or Master Card. Burton will also accept partial or full payment by the assignment of life insurance proceeds in the verified amount of proceeds payable. If this option is selected, the beneficiary or beneficiaries of the policy or policies will execute a limited power of attorney, assigning to Burton the right to the proceeds and granting to Burton the authority to process the claim. Non-payment under the policy does not affect the obligation to otherwise honor this contract.
4. While the person signing this and other contracts may make a claim for reimbursement from the decedent's estate, any non-payment by the estate does not affect the obligation to pay according to this contract.
5. Any amounts not paid by the due date in the "Statement of Funeral Goods and Services Rendered" will result in interest being added to the amount due at the rate of **1.25%** per month (**15%** per year). In addition to interest, the person signing this contract will also reimburse Burton for any legal fees it incurs in an attempt to collect amounts not paid by the due date.
